# Mapping Link Install

These notes describe how the Confirm Mapping Link for any DDE or Command Line compatible GIS application is installed on a Workstation where Confirm has already been installed. They are designed to allow technically aware users with a working knowledge of the DDE / Command Line compatible GIS application to install software on the Installation Server and client Workstations.

This document only covers the Confirm aspects of the installation. Separate instructions are required to configure the GIS application.

After reading these notes you should be able to:

- Install and test the Confirm Mapping Link on a new Workstation

The guide should be used in conjunction with the **Mapping Link API Specification**.

# Installing Confirm Mapping Link

## INSTALLATION SERVER INSTALL

The Installation Server contains the networked installation files for the Confirm application and the Confirm Mapping Link files.

This section describes how to setup the Confirm Mapping Link installation files on an installation server so that it is suitable to be used for workstation installations. Confirm will not be supplying the Confirm Mapping Link files.

### Installation Server Directory Structure

The following table shows the preferred directory structures for the Confirm Mapping Link installation files on the Installation Server. The DirNames referred to in the table are used to identify the target directory and its function and are referenced in the remainder of the document.

| Installation Server Name: |  |  |
|---------------------------|--|--|
| Preferred Directory       | DirName                                  | Description  |
| SBS\INSTALL\              | Install Server root                      | Root directory for installation files                                    |

| Client\Confirm            | CONFIRM Application Installer Directory  | Installation files for the Confirm application for PC workstations       |
| Client\Confirm\GIS        | CONFIRM Mapping Link Installer Directory | Installation files for workstation installs of the Confirm Mapping Link. |

If a different structure is adopted from the one recommended, then this should be recorded and made available to Confirm and its appointed support agents for support purposes.

Set up the directory structure on the Installation server as defined in the above table, and copy the Mapping Link files to the Confirm Mapping Link Installer Directory.

## WORKSTATION INSTALLATION

This section describes how to install the Confirm Mapping Link onto a client Workstation. This process will need to be performed for each client Workstation.

### Client Workstation Directories

The table below displays the preferred workstation installation directory structure.

Create the directory structure on the Workstation as defined in the table above and copy the Confirm Mapping Link program files from the Confirm Mapping Link Installer Directory to the Confirm Mapping Link Application directory. Again, Confirm do not provide these files.

## Client Workstation Configuration

### Confirm Registry Settings

All registry settings for the Confirm applications reside off the following key:

- HKEY\_LOCAL\_MACHINE\Software\SouthBank Systems

Each Confirm application installed on a workstation has its own key in the registry which resides under the key specified above and is named the same as the Confirm application. The Confirm applications relevant to the Mapping Link are: Confirm Arboriculture, Confirm Engineering, Confirm Enterprise, Confirm Environmental, Confirm Highways, Confirm Pavement Manager, Confirm Property, Confirm Street Lights and Confirm Street Works.

### Confirm Mapping Link Registry Settings

For each Confirm application that is to have the Confirm Mapping Link enabled, create the following keys in the Registry under ...Software\SouthBank Systems\<Confirm Application Name>\Mapping:

| <b>Key</b>    | <b>Description</b>                                    |
|---------------|---|
| CurrentEngine | The name of the current Mapping Link used by Confirm. |
| Engine1       | The name of the first Mapping Link.                   |
| Engine2       | The name of the second Mapping Link.                  |

Where the Confirm application is to have only one Mapping Link configured, it is only necessary to create the CurrentEngine and Engine1 keys. Where multiple Mapping Links are to be configured, the CurrentEngine key must be populated and the name of the Mapping Link (e.g. WINMAP) populated against a unique engine key (e.g. Engine1).

Create a new key under the Software\SouthBank Systems\<Confirm Application Name>\Mapping key with the name of the Mapping Link. This name must be the same as the value set against the Engine key.

E.g. Software\SouthBank Systems\Confirm Highways\Mapping\WinMap

The following keys are then to be populated for the Mapping Link under the key created in the above step under ...Software\SouthBank Systems\>Asset Type<\Mapping\>Mapping Link Name<:

| <b>Key</b>      | <b>Description</b>   |
|-----------------|--|
| ApplicationName | Set to the name of the GIS server application (Mapping application) for DDE purposes or the full |

| Key            | Description  |
|----------------|--|
| LinkType       | path name of the application for Command Line interface purposes.<br>EXE if using command line interface and DDE (or blank) if using DDE interface.                        |
| TopicName      | Set to 'System'. Setting not required if LinkType is set to EXE.   |
| ExportFile     | The path to the con2gis.txt file, which is used to temporarily store data, sent from Confirm to the Mapping application. This is set to 'c:\sbs\Transfer\GIS\con2gis.txt'. |
| SelectCommand  | Set to the command for showing asset details in the Mapping application for selections made within Confirm.  |
| UpdateCommand  | Set to the command for updating asset details in the Mapping application for selections made within Confirm.   |
| XYCommand      | Set the command used to instruct the Mapping application to zoom to a specified point and display the text annotation  |
| DeleteCommand  | Set the command used to instruct the Mapping application to delete the specified assets  |
| DynaSegCommand | Set the command used to instruct the Mapping application to draw linear events   |
| DynaSegFile    | The path to the temporary file that will be used in the DynaSegCommand   |

### Testing DDE

If no GIS exists, then a DDE test with Microsoft Excel can be performed with the following settings:

```
ExportFile=C:\SBS\TRANSFER\GIS\CONTOMAP.TXT
ApplicationName=EXCEL
TopicName=system
UpdateCommand=[open ("%1")]
SelectCommand=[open ("%1")]
```

### Sending Features from Confirm

Start Confirm and open the Select Features for Map window. Find an appropriate Site, select two features and click on the Update button.

Excel will not necessarily take focus, but it should have open the CONTOMAP.TXT file, with column headings and feature information displayed in quotes.

### Sending Features back to Confirm

To send features back into Confirm, open Explorer, choose View, Options or Folder Options, and choose File Types. Find Text Document, select and choose Edit. Click New. Enter a new action name, for example Confirm. In the box "Application used to perform action" enter the path to the executable 'notepad.exe' (usually in the c:\windows directory). Check the Use DDE check box and a number of new fields appear. Fill them in using the following screen shot as an example:

Edit the textfile used to send data from Confirm to Excel. It should only have one "item" in it, and should look something like the following:

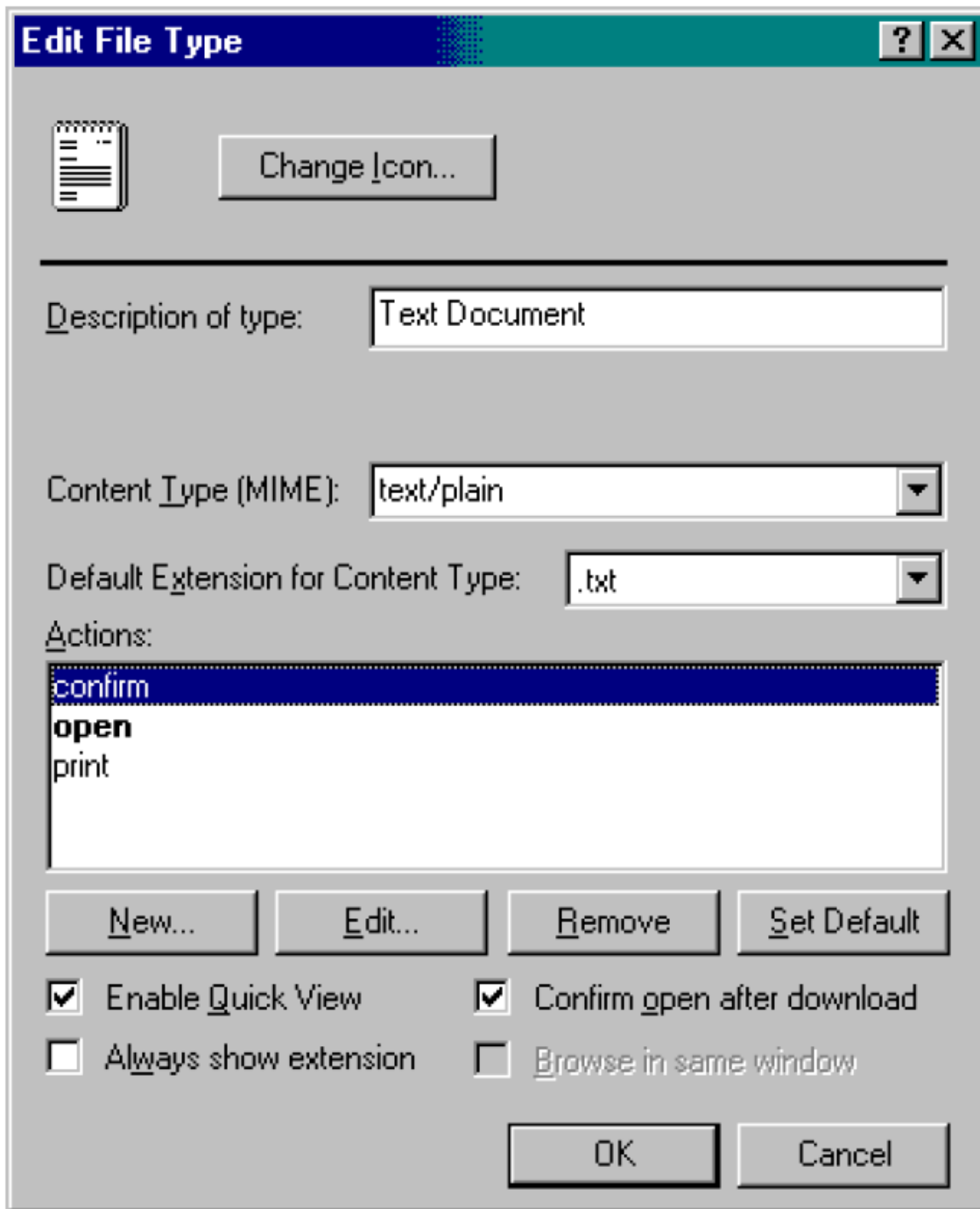
```
Asset Id
ABBEYCRT0000002300
```

Once this file has been saved, make sure Confirm is open, then right click your saved file. One of the options from the menu should be Confirm. When you select this, it should have the effect whereby Confirm will come to the front, and be the currently active application. Confirm should then show you the feature or section details for the item that was in the file.

These tests require to be carried out on each of the PC's designated to be installed with the Confirm Mapping link.

### Tidy Up - Removing DDE entries

If testing has been done without a GIS installed, DDE entries created to facilitate testing now need to be removed. This is done by opening Explorer, choose View, Options or Folder Options, and choose File Types. Find Text Document, select and choose Edit. In the Actions window, select the Confirm action added previously and click the Remove button.



### Testing the Command Line Interface

If no GIS exists, then a Command Line test with Notepad can be performed with the following settings:

```
ExportFile=C:\SBS\TRANSFER\GIS\CONTOMAP.TXT
ApplicationName=Notepad.exe
LinkType=EXE
UpdateCommand="%1"
SelectCommand="%1"
```

### Sending Features from Confirm

Start Confirm and open the Select Features for Map window. Find an appropriate Site, select two features and click on the Update button. Notepad should take focus and open the CONTOMAP.TXT file, with column headings and feature information displayed in quotes.

## TROUBLESHOOTING

### Problems Invoking Mapping link

#### **DDE communications error. Link not started**

This is displayed when Confirm cannot establish communication with the Target Application. Make sure that the application is loaded at the same time.

#### **DDE communications error unable to open output file.**

This may be caused by the ExportFile in the Local Mapping Transfer directory being used by another program. Remove any other references to the ExportFile (contomap), i.e. close any applications that may have the file open.

Also make sure that the ExportFile directory exists and is correct.

#### **Command Line link communications error. Link failed**

This is displayed when Confirm cannot establish communication with the Target Application. Make sure that the application path name is correct.
